RESOLUTION NO. 175

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO CONSTITUTE THE CITY REGISTRATION COMMITTEE AND TO APPOINT/DESIGNATE THE MEMBERS THEREOF PURSUANT TO RA 7279, OTHERWISE KNOWN AS THE URBAN DEVELOPMENT AND HOUSING ACT (UDHA).

WHEREAS, Section 17 of RA 7279, otherwise known as the Urban Development and Housing Act (UDHA) and its Implementing Rules and Regulations and Presidential Proclamation No. 397 mandate the Local Government Units (LGUs) to undertake the registration of potential socialized housing beneficiaries;

WHEREAS, the conduct of said registration is imperative to facilitate the implementation of the Urban Development and Housing Act towards the alleviation of the plight of our homeless and underprivileged constituents;

WHEREAS, this august Body understands that once constituted the City Registration Committee shall facilitate the creation of, and provide orientation for the Barangay Registration Committee;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by Kagawad Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO CONSTITUTE THE CITY REGISTRATION COMMITTEE AND TO APPOINT/DESIGNATE THE MEMBERS THEREOF PURSUANT TO RA 7279, OTHERWISE KNOWN AS THE URBAN DEVELOPMENT AND HOUSING ACT (UDHA);
