WHEREAS, Section 17 of RA 7279, otherwise known as the Urban Development and Housing Act (UDHA) and its Implementing Rules and Regulations and Presidential Proclamation No. 397 mandate the Local Covernment Units (LGUs) to undertake the registration of potential socialized housing beneficiaries;

WHEREAS, the conduct of said registration is imperative facilicate the implementation of the Urban Development and Housing Act the alleviation of the plight of our homeless underpriveleged constituents;
