A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. TODILLY, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVER WENT OF ORMOC, AS DONOR, A DEED OF DONATION WITH BARANGAY DOLORES, REPRESENTED IN 1813 INSTRUCTOR OF CAPTAIN ULDARICO TANEO, AS DONEE, COVERING A FORTION OF CAPTAIN ULDARICO TANEO, AS DONEE, COVERING A FORTION OF DECLARATION NO. 16974 WITH AN AREA OF 2,438 SQUARE NO. X325 GITUARED IN BRGY. DOLORES, ORMOC CITY WITH TEXERS TO BE USED AS BARANGAY MULTI-PURPOSE SITE.

WYEREAS, the City Government of Ormoc represented by the Hon. City as Donor, has donated to Barangay Dolores, represented by Brgy.
