A RESOLUTION SUPPORTING RESOLUTION NO. 418 S. 1994 OF THE
SANGGUNIANG PANLUNGSOD OF BAGUIO, ENTITLED, "A RESOLUTION
STRONGLY ENDORSING TO THE CONGRESS OF THE PHILIPPINES THE
ENACTMENT OF THE BILL SPONSORED BY SENATOR RAUL S. ROCO
PROVIDING FOR SAFEGUARDS IN THE DISBURSEMENT OF THE
COUNTRYWIDE DEVELOPMENT FUND BY PROHIBITING MEMBERS OF
CONGRESS AND THEIR RELATIVES WITHIN THE 4TH CIVIL DEGREE
OF CONSANGUINITY OR AFFINITY FROM PARTICIPATION DIRECTLY
OR INDIRECTLY IN BIDDING, CONTRACTING, AND IMPLEMENTING
PUBLIC WORKS PROJECTS".

safeguards in the disbursement of the Countrywide Development Fund by
prohibiting members of Congress and their relatives within the 4th Civil
Degree of Consanguinity or Affinity from participation directly or
indirectly in bidding, contracting, and implementing public works
projects;


