A RESOLUTION TRANSFERRING THE DATES OF THE REGULAR SESSION
ON NOVEMBER 3, 1994 AND THE PRE-SESSION CAUCUS ON NOVEMBER
1, 1994 TO NOVEMBER 4, 1994 AND NOVEMBER 2, 1994,
RESPECTIVELY, WITH THE PRE-SESSION CAUCUS ON NOVEMBER 2ND
TO START AT 9:00 A.M., IMMEDIATELY AFTER THE FLAG CEREMONY.

WHEREAS, as per internal rules or regulations of the Sangguniang
Panlungsod, its regular sessions shall fall on every Thursday of the
week, and by practice, pre-session caucuses thereof shall fall on every
Tuesday of every week;

WHEREAS, November 1, 1994, which is a Tuesday, is officially
declared a non-working holiday, hence, incapable of conducting a pre-

to follow forthwith; and

WHEREAS, if the immediately next pre-session caucus is moved to
another date, by analogy, it also become a must to set another date for

between these two sets of interrelated and connecting activities of the
Sangguniang Panlungsod;
