HEREAS, November 1, 1994, which is a Tuesday, is officially declared a non-working holiday, hence, incapable of conducting a presession caucus as a preparatory informal meeting for a regular session to follow forthwith; and

WHEREAS, if the immediately next pre-session caucus is moved to another date, by analogy, it also become a must to set another date for its forthcoming regular session, to provide a reasonable gap of time in between these two sets of interrelated and connecting activities of the Sangguniang Panlungsod;

NOW, THEREFORE, on motion of Kagawad Sotero M. Pepito, Chairman, Committee on Good Government & Ethics, duly seconded by Kagawad Celso P. Adolfo; be it

RESOLVED, to pass a resolution TRANSFERRING THE DATES OF THE REGULAR SESSION ON NOVEMBER 3, 1994 AND THE PRE-SESSION CAUCUS ON NOVEMBER 1, 1994 TO NOVEMBER 4, 1994 AND NOVEMBER 2, 1994, RESPECTIVELY, WITH THE PRE-SESSION CAUCUS ON NOVEMBER 2ND TO START AT 9:00 A.M., IMMEDIATELY AFTER THE FLAG CEREMONY;
