RESOLUTION NO. 183

A RESOLUTION CONFIRMING THE DEED OF DONATION ENTERED INTO
BETWEEN THE CITY OF ORMOC, A LOCAL GOVERNMENT UNIT,
REPRESENTED BY THE HONORABLE CITY MAYOR EUFROCINO M.
CODILLA, SR., AS DONEE AND THE SPS. SUSANA B. RUEDAS AND
DESIDERIO RUEDAS, AS DONORS, OF A PARCEL OF LAND (LOT NO.
10233) WITH THE BUILDING AND ITS IMPROVEMENTS THEREON,
SITUATED AT BRGY. MONTERICO, ORMOC CITY WITH AN AREA OF
10,000 SQ. METERS TO BE USED AS BARANGAY SITE OF SAID
BARANGAY.

WHEREAS, the Sps. Susana B. Ruedas and Desiderio Ruedas, residents
of Naghalin, Kananga Leyte has donated to the City Government of Ormoc
represented by the Honorable City Mayor Eufrocino M. Codilla, Sr., as
Donee, a parcel of land (Lot No. 10233) with the building and its
improvements thereon, situated at Brgy. Monterico, Ormoc City with an
area of 10,000 sq. meters covered by TCT No. 20637 to be used as
barangay site of said barangay;

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc through the
representation of the Honorable Kagawad-In-Charge of Brgy. Monterico has
considered said donation as valid and reasonable hence, confirmation
thereof by this august Body is in order;

Charge of Brgy. Monterico, jointly seconded by Kagawad Benjamin B.
Lladoc and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution confirming
the Deed of Donation entered into between the City of Ormoc, a Local
Government Unit, represented by the Honorable City Mayor Eufrocino M.
Codilla, Sr., as Donee and the Sps. Susana B. Ruedas and Desiderio
Ruedas, as Donors, of a parcel of land (Lot No. 10233) with the building

and its improvements thereon, situated at Brgy. Monterico, Ormoc City with an area of 10,000 sq. meters to be used as barangay site of said barangay;
