A RESOLUTION CONTINUING THE DEED OF DONATION ENTERED INTO BETWEEN THE CITY OF DRADC, A LOCAL GOVERNMENT UNIT, THE HONORABLE CITY MAYOR EUFROCINO M. REPRESENTED BY FA. AS DONCE AND THE SPS. SUSANA B. RUEDAS AND DESIDIATO WEDAS, AS DONORS, OF A PARCEL OF LAND (LOT NO. RUILDING AND ITS IMPROVEMENTS THEREON, AT BRZY. MONTERICO, ORMOC CITY WITH AN AREA OF METERS TO BE USED AS BARANGAY SITE OF SAID BARANGAY.

WHEREAS, the Sps. Susana B. Ruedas and Desiderio Ruedas, residents Naghalin, Kananga Leyte has donated to the City Government of Ormoc represented by the Honorable City Mayor Eufrocino M. Codilla, Sr., as Dovee, a parcel of land (Lot No. 10233) with the building and its improvements thereon, situated at Brgy. Monterico, Ormoc City with an area of 10,000 sq. meters covered by TCT No. 20637 to be used as barangay site of said barangay;
