## RESOLUTION NO.

A RESOLUTION TO DISAPPROVE TAX ORDINANCE NO. 01 S. 1993 ENTITIED, "AN ORDINANCE CHARGING A FEE ON THE USE OF THE ENTITLED, BARANGAY BASKETBALL COURTS OR ANY PORTION OF THE BARANGAY MULTI PURPOSE PAVEMENTS FOR DRYING GRAINS AND SIMILAR MATERIALS." OF THE SANGGUNIANG PAMBARANGAY OF MARGEN FOR THE REASON THAT AS SHOWN THEREIN THE REQUIRED PUBLIC HEARING WAS MADE LONG AFTER THE ENACTMENT OF SUBJECT ORDINANCE CONTRARY TO THE PROVISIONS OF SEC. 186 OF THE LOCAL GOVERNMENT CODE OF 1991, WHICH PROVIDES IN PART "THAT ORDINANCE LEVYING SUCH TAXES, FEES OR CHARGES, SHALL NOT BE ENACTED WITHOUT ANY PRIOR PUBLIC HEARING CONDUCTED FOR THE PURPOSE".

WHEREAS, this august Body is in receipt of Tax Ordinance No. 01 s. 1993 of the Barangay Council of Margen, this city entitled, "AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY BASKETBALL COURTS OR ANY PORTION OF THE BARANGAY MULTI-PURPOSE PAVEMENTS FOR DRYING GRAINS AND SIMILAR MATERIALS";

WHEREAS, the Sixth Sangguniang Panlungsod through representation of the Honorable Chairman, Committee on Laws Ordinances recommends for the disapproval of said Tax Ordinance for the reason that as shown therein the required public hearing was made long after the enactment of the subject ordinance contrary to the provisions of Sec. 186 of the Local Government Code of 1991, which provides in part "that ordinance levying such taxes, fees or charges, shall not be enacted without any prior public hearing conducted for the purpose;"

NOW, THEREFORE, premises considered on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances duly seconded by Kagawad Sotero M. Pepito; be it
