RESOLUTION NO. 193

A RESOLUTION TO INFORM THE HONORABLE CITY MAYOR OF ORMOC, EUFROCINO M. CODILLA, SR., THAT THE SITE WHERE THE PROPOSED RESTAURANT OF MR. VANS MASCARINAS IS TO BE CONSTRUCTED IS NOT OWNED BY THE CITY GOVERNMENT OF ORMOC BUT BY THE NATIONAL GOVERNMENT AND OTHER PRIVATE PERSONS PER INFORMATION OF CITY ENGINEER RUBEN C. PENSERGA CONTAINED IN HIS 4TH INDORSEMENT DATED NOVEMBER 10, 1994, HENCE THIS SANGGUNIAN CANNOT GIVE DUE COURSE TO MR. MASCARINAS' LEASE APPLICATION.

WHEREAS, this august Body is in receipt of a letter dated 14 October 1994 from the Honorable City Mayor, Eufrocino M. Codilla, Sr., addressed to the Honorable Members of the Sixth Sangguniang Panlungsod, this city, thru the Hon. Vice Mayor and Presiding Officer, requesting approval of the Proposed Project of Mr. Vans Mascarinas, c/o VM's Pharmacy, this city, for the construction of a first class restaurant a "SEA FOODS PARK" at the sea side in front of Shell, Camp Downes, this city;

WHEREAS, the City Engineer, through 4th Indorsement dated 10 November 1994 has informed the Committee on Public Properties that, "In accordance with the approved Road Inventory of the city, the 20 m. wide concrete road belongs to the National Government while those subject lots along the sea coast are privately owned by different individuals as per tax mapping records";

WHEREAS, the Sixth Sangguniang Panlungsod through the representation of the Honorable Chairman, Committee on Public Properties cannot give due course to the lease application of Mr. Mascarinas for the reason that the site where the proposed first class restaurant is to be constructed is not owned by the City Government of Ormoc but by the National Government and other private persons per information given by the City Engineer contained in his 4th Indorsement dated 10 November 1994;

WHEREAS, if ever this restaurant will be established in this particular area, it will create also a traffic problem since the road referred to here is a national road and even though a parking space is provided for in the drawing plan, there is a doubt as to whether it is feasible in that particular area;

NOW, THEREFORE, premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by Kagawad Benjamin B. Lladoc and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution informing the Hon. City Mayor of Ormoc, Eufrocino M. Codilla, Sr., that the site where the proposed restaurant of Mr. Vans Mascariñas is to be constructed is not owned by the City Government of Ormoc but by the National Government and other private persons per information of City Engineer Ruben C. Penserga contained in his 4th Indorsement dated November 10, 1994, hence this Sanggunian cannot give due course to Mr. Mascariñas' Lease Application;

ENACTED, November 17, 1994.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, Mr. Vans Mascariñas and others concerned, -all in Ormoc City;
