

A RESOLUTION APPROVING ORDINANCE NO. 94-001 S. 1994 OF THE
BARANGAY COUNCIL OF ESPERANZA ENTITLED, "AN ORDINANCE
PROHIBITING THE USE OF INSECTICIDES AND OTHER POISONOUS
SUBSTANCES IN RIVERS, STREAMS, AND OTHER PUBLIC WATERS,
WITHIN THE JURISDICTION OF THE BARANGAY, FOR THE PURPOSE
OF CATCHING FISHES, AND OTHER AQUATIC RESOURCES, PROVIDING
PENALTIES THEREOF".

WHEREAS, this august Body is in receipt of Ordinance No. 94-001 s.


