RESOLUTION NO. 202

A RESOLUTION CONFIRMING THE APPOINTMENT OF MRS. MARIETTA S. LEGASAY AS SITY SOCIAL NELFARE AND DEVELOPMENT OFFICER OF THE LOCAL BOVERNMENT OF GRADE CITY.

PRESENTED for confirmation by this august Body, through 1st Indorsement dated 9 November 1994 from the Honorable City Mayor, is the Appointment of Mrs. Marietta S. Legaspi as City Social Welfare and Development Officer.

WHEREAS, Art. 119, Par. (a) - Rules and Regulations Implementing the Local Government Code of 1991 provides:

"(a) Unless otherwise provided in this Rule, heads of offices and departments in the LGUs shall be appointed by the local chief executive concerned with the concurrence of a majority of all the members of the sanggunian, subject to civil service laws, rules and regulations."

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Good Government & Ethics, finds that the appointment of Ms. M. S. Legaspi to the said position is in accordance with pertinent provisions of the Local Government Code;

NOW, THEREFORE, on motion of Kagawad Sotero M. Pepito, Chairman, Committee on Good Government & Ethics, duly seconded by Kagawad Jose B. Conejos; be it
