RESOLUTION NO. 203

A RESOLUTION CONFIRMING THE APPOINTMENT OF MRS. CRISTINA C.

PRESENTED for confirmation by this august Body, through 1st  
Indorsement dated 9 November 1994 from the Honorable City Mayor, is the  
Appointment of Mrs. Cristina C. Con-ui as City Planning and Development  
Coordinator.

WHEREAS, Art. 119, Par. (a) - Rules and Regulations Implementing  
the Local Government Code of 1994 provides:

" (a) Unless otherwise provided in this Rule, heads of  
offices and departments in the LGUs shall be appointed by the  
local chief executive concerned with the concurrence of a  
majority of all the members of the sanggunian, subject to civil  
service laws, rules and regulations."

Honorable Chairman, Committee on Good Government & Ethics, finds out  
that the appointment of Mrs. C. C. Con-ui to the said position is in  
accordance with pertinent provisions of the Local Government Code;

Committee on Good Government & Ethics, severally seconded by mga Kagawad  
Nestor C. Penserga, Claudio A. Larrazabal and Alfredo F. Capahi; be it

RESOLVED, to pass a resolution CONFIRMING THE APPOINTMENT OF MRS.  
CRISTINA C. CON-UI AS THE CITY PLANNING AND DEVELOPMENT COORDINATOR OF  
THE LOCAL GOVERNMENT OF ORMOC CITY;

ENACTED, November 24, 1994.


