119 Par. (a) - Rules and Regulations Implementing the WHEREAS, Art. ocal Government Code provides:

"(a) Unless otherwise provided in this Rule, heads of offices and departments in the LGUs shall be appointed by the local chief executive concerned with the concurrence of a majority of all the members of the sanggunian, subject to civil service laws, rules and regulations."

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Good Government & Ethics, finds out that the appointment of Dr. A. P. Apoderado to the said position is in accordance with pertinent provisions of the Local Government Code;
