RESOLUTION NO. 206

A RESOLUTION CONFIRMING THE APPOINTMENT OF DR. AMANDO P.  
APODERADO AS CITY VETERINARIAN OF THE LOCAL GOVERNMENT OF  
ORMOC CITY.

PRESENTED for confirmation by this august Body, through 1st  
Indorsement dated 2 November 1994 from the Honorable City Mayor, is the  
Appointment of Dr. Amando P. Apoderado as City Veterinarian.

WHEREAS, Art. 110 Par. (a) - Rules and Regulations Implementing the  
Local Government Code provides:

"(a) Unless otherwise provided in this Rule, heads of  
offices and departments in the LGUs shall be appointed by the  
local chief executive concerned with the concurrence of a  
majority of all the members of the sanggunian, subject to civil  
service laws, rules and regulations."

WHEREAS, this august Body, through the representation of the  
Honorable Chairman, Committee on Good Government & Ethics, finds out  
that the appointment of Dr. A. P. Apoderado to the said position is in  
accordance with pertinent provisions of the Local Government Code;

Committee on Good Government of Ethics, severally seconded by mga  
Kagawad Sixto T. Pongos, Claudio P. Larrazabal, Jose C. Alfaro, Jr. and  
Fernando P. Parrilla; be it

AMANDO P. APODERADO AS CITY VETERINARIAN OF THE LOCAL GOVERNMENT OF  
ORMOC CITY;
