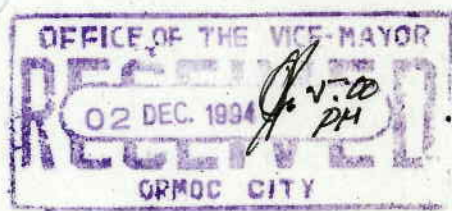

ENACTED, December 1, 1994.

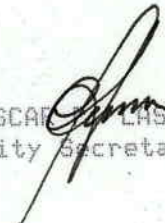

CARRIED UNANIMOUSLY.

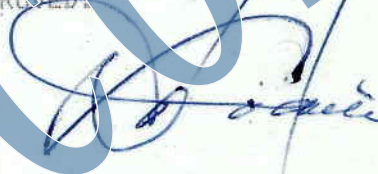
