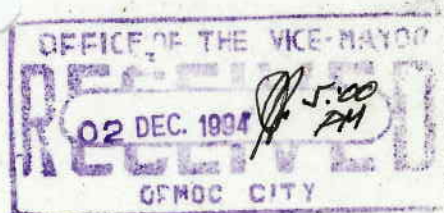

RESOLUTION NO. 214

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO
M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY
GOVERNMENT OF ORMOC, AS DONEE, A DEED OF DONATION WITH THE
SPOUSES HERCULANO D. GARCIA AND MARIA PERMITES GARCIA, AS
DONORS, INVOLVING A PARCEL OF LAND SITUATED AT BARANGAY
ALEGRIA, ORMOC CITY, TO BE USED AS BARANGAY ROAD FOR
BARANGAY PUNTA, ORMOC CITY.

HEREAS, this august Body is in receipt of an Indorsement from the
Honorable City Mayor, requesting for the passage of a resolution
authorizing the latter to sign for and in behalf of the City of Ormoc as
Donee, a Deed of Donation with the Spouses Herculano D. Garcia and Maria
Permites Garcia, as Donors, involving a parcel of land, Lot 2347-B-6-B-7
of the subdivision plan, Psd-08-002626, being a portion of Lot 2347-B-6-
B, Psd-08-001046 situated at Barangay Alegria, this city, containing an
area of 420 square meters more or less to be used as barangay road for
Barangay Punta, this city;

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc, through the
representation of the Honorable Chairman, Committee on Public
Properties, has considered said donation as valid and reasonable, hence,
confirmation thereof by this august Body is in order;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman,
Committee on Public Properties, jointly seconded by Kagawad Benjamin B.
Lladoc and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution
authorizing the Honorable City Mayor Eufrocino M. Codilla, Sr., to sign
for and in behalf of the City Government of Ormoc, as Donee, a Deed of
Donation with the Spouses Herculano D. Garcia and Maria Permites Garcia,
as Donors, involving a parcel of land situated at Barangay Alegria,
Ormoc City, to be used as Barangay Road for Barangay Punta, Ormoc City;
