RESOLUTION NO. 227

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO N. CODN LA. SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, HEREINAFTER CALLED THE PARTY OF THE SECOND PART, A DEED OF EXCHANGE WITH MR. CORNELIO TAJOR, HEREINAFTER CALLED THE PARTY OF THE FIRST PART, INVOLVING LOT NO. 8708-B WITH AN AREA OF 9,740 SQUARE METERS AND ONLY A PORTION THEREOF IS SUBJECT OF THE DEED OF EXCHANGE CONTAINING AN AREA OF 260 SQUARE METERS OWNED POSSESSED BY THE CITY GOVERNMENT OF ORMOC AND LOT 8707-0-3-I WITH AN AREA OF 9,874 SQUARE METERS, LIKEWISE, ONLY A PORTION THEREOF IS SUBJECT TO THE DEED OF EXCHANGE CONTAINING AN AREA OF 260 SQUARE METERS, OWNED AND POSSESSED BY MR. CORNELIO TAJOR, BOTH SITUATED AT BARANGAY MATICA-A, THIS CITY.

WHEREAS, this august Body is in receipt of an indorsement from the Honorable City Mayor dated 7 October 1994 requesting for the passage of a resolution authorizing the latter to sign for and in behalf of the City Government of Ormoc, hereinafter called as the Party of the Second Part, a Deed of Exchange with Mr. Cornelio Tajor, hereinafter called as the Party of the First Part involving Lot No. 8708-B with an area of 9,740 sq. meters and only a portion thereof is subject of the Deed of Exchange containing an area of 260 sq. meters owned and possessed by the City Government of Ormoc and Lot No. 8707-0-3-I with an area of 9,874 sq. meters, likewise, only a portion thereof is subject of the Deed of Exchange containing an area of 260 sq. meters, owned and possessed by Mr. Cornelio Tajor, both situated at Barangay Matica-a, this city;

WHEREAS, said request is based solely on the purpose of exchanging a portion of Lot No. 8707-Q-3-I owned by Mr. Cornelio Tajor which is used as an existing road going to the Multi-Purpose Site of Barangay Matica-a with a portion also of Lot No. 8707-B, owned by the City Government of Ormoc, both situated at the said barangay;

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc, through the representation of the Honorable Chairman, Committee on Public Properties, has considered said request as valid and reasonable, hence, confirmation thereof by this august Body is in order;

NOW, THEREFORE, on motion of Kagawad Mariano Corro, Chairban, Committee on Public Properties, jointly seconded by Kagawad Sotero M. Pepito and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR FUFRCCIND M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORNOC, HEREINAFTER CALLED THE PARTY OF THE SECOND PART, A DEED OF EXCHANGE WITH MR.
