RESOLUTION NO. 237

A RESOLUTION EXTENDING THE DEADLINE OF PAYMENT RE TAX  
AMNESTY ON REAL PROPERTIES ON OR BEFORE DECEMBER 31, 1994  
TO MARCH 31, 1995.

WHEREAS, this sanggunian had passed Resolution No. 42 s. 1994  
adopting Ordinance No. 40, otherwise known as the 1994 ORMOC CITY TAX  
AMNESTY ON REAL PROPERTIES;

WHEREAS, Section 3 thereof has provided that "all penalties on  
unpaid real property taxes for 1993 and prior years which are still due  
and collectible are hereby CONDONED, PROVIDED that the taxes due thereon  
must be paid not later than December 31, 1994. THEREAFTER, all the  
remedies for the collection of real property tax as provided for in  
Republic Act 7160, otherwise known as the Local Government Code of 1991,  
shall be strictly enforced by the City Treasurer in the collection of  
delinquent real property taxes";

WHEREAS, however, quite a number of taxpayers, civic organizations  
and landowners have made representations to the City Government and this  
sanggunian requesting for extension of the deadline on payment re Tax  
Amnesty on Real Properties on or before December 31, 1994 to March 31,  
1995 due to economic hardships brought about by natural calamities  
especially typhoon "Garding" which hit Ormoc City on December 21, 1994;

WHEREFORE, to relieve the economic woes of the people of Ormoc City  
and, to encourage them in paying their delinquent real property taxes,  
on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance,  
severally seconded by mga Kagawad Mariano Y. Corro, Benjamin B. Lladoc,  
Jose C. Alfaro, Jr., Sixto T. Pongos and Claudio P. Larrazabal; be it



RESOLVED, to pass a resolution EXTENDING THE DEADLINE OF PAYMENT RE TAX AMNESTY ON REAL PROPERTIES ON OR BEFORE DECEMBER 31, 1994 TO MARCH 31, 1995;

ENACTED, December 29, 1994.
