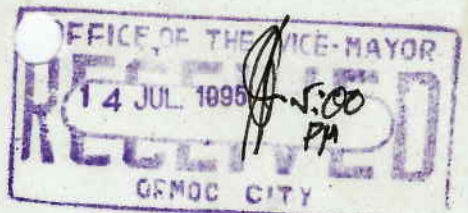

RESOLUTION NO. 95-12

A RESOLUTION RESPECTFULLY REQUESTING THE CONGRESS OF THE PHILIPPINES, THROUGH THE PRESIDENT OF THE SENATE, HON. EDGARDO ANSARA, AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, HON. JOSE DE VENECIA, JR., TO ENACT INTO LAW SENATE BILL NO. 1932 AND HOUSE BILL NO. 13680 WHICH SEEK TO AMEND SECTION 325 (A) OF REPUBLIC ACT 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, there is now pending in both Houses of Congress of the Philippines, Senate Bill No. 1932 and House Bill No. 13680 which seek to amend Section 325 (a) of Republic Act 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the proposed amendment seeks to confine to salaries and wages as the only bases in limiting local government appropriation for "PERSONAL SERVICES", thereby excluding other items such as representation, travel and other allowances, bonuses and the like, in the limitation thereof which must not exceed 45% in the case of first to third class provinces, cities and municipalities, and 55% in the case of fourth class or lower, of the total annual income from regular sources realized in the next preceding fiscal year;

WHEREAS, the proposed amendment if enacted into law would give LGUs more elbow room in determining allocations in their budget with a more realistic and reasonable allocation limit;

WHEREFORE, on MASS MOTION of the Body and with OVERWHELMING SECONDS; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution respectfully requesting the Congress of the Philippines, through the President of the Senate, Hon. Edgardo Angara, and the Speaker of the House, Hon. Jose de Venecia, Jr., to enact into law Senate Bill No. 1932 and House Bill No. 13680 which seek to amend Section 325 (a) of Republic Act 7160, otherwise known as the Local Government Code of 1991;

RESOLVED, FURTHER, to furnish copies of this Resolution, one each, to the President of the Senate, Hon. Edgardo Angara; the Speaker of the House of Representatives, Hon. Jose de Venecia, Jr.; the Secretary of the Department of Interior and Local Government, Hon. Rafael Alunan all of Metro Manila; the Regional Director, DILG, Tacloban City; the City Mayor of Ormoc, Hon. Eufrocino M. Codilla, Sr., and all others concerned;
