RESOLUTION NO. 13

A RESOLUTION INFORMING THE HONORABLE CITY MAYOR EUFROCINO M. CORILLA, SR. THAT THE REQUEST OF IAL ENTERPRISES TO EXCHANGE ITS PROPERTY WITH "NO NAME STREET" CANNOT BE ACTED FAVORABLY BY THIS SANGGUNIANG CONSIDERING THAT THERE IS NO PROOF THAT "NO NAME STREET" IS OWNED BY THE CITY GOVERNMENT OF ORMOC.

WHEREAS, the IAL Enterprises, Inc., this city, through its letter dated 2 December 1994, has requested the City Government through the Honorable City Mayor for an exchange of its lot (OBRERO STREET) containing an area of 716 square meters, with the area of NO NAME STREET of 733 square meters, both located between San Pedro and San Pablo Streets, Ormoc City;

WHEREAS, the following are significant findings and reports from requested agencies of the city government relative to the said two (2) lots which are the subjects of the proposed barter:

- a) "The proposed "NO NAME STREET" reserved for cadastral road under public domain is currently not titled to the government and that Obrero Street (existing road) is titled in the name of Ifaki Larrazabal Enterprises, Inc., a part and parcel of Lot No. 830-A." (No. 5 of 2nd Par. of Letter dated 16 December 1994, City Planning & Development Coordinator).
- b) "X X X X Verification with the records of the Register of Deeds, Ormoc City, fails to show any existing title of NO NAME STREET." (4th Indorsement dated 29 December 1994, City Engineer).

- c) "Calle (NO NAME) adjoining Lots Nos. 115, 120, 123 and 830, has no title issued in itself being separately surveyed as a Cadastral Road secured and reserved for public use." (Par. 1 of 5th Indorsement dated 20 December 1994, Tax Mapper IV (Geodetic Engineer)).

WHEREAS, based on the findings as aforecited, NO NAME STREET is a public land and belongs to the National Government;

NOW, THEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, duly seconded by Kagawad Nestor C. Penserga; be it


RESOLVED, to pass a resolution INFORMING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. THAT THE REQUEST OF IAL ENTERPRISES TO EXCHANGE ITS PROPERTY WITH "NO NAME STREET" CANNOT BE ACTED FAVORABLY BY THIS SANGGUNIAN CONSIDERING THAT THERE IS NO PROOF THAT "NO NAME STREET" IS OWNED BY THE CITY GOVERNMENT OF ORMOC;

ENACTED, January 26, 1995.

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Planning & Development Coordinator, the City Engineer, the Tax Mapping Division Office, and the President & General Manager-IAL Enterprises, Inc., all in Ormoc City;

CARRIED by MAJORITY VOTES, with six (6) affirmative votes, three (3) abstentions registered by mga Kagawad Sotero M. Pepito, Claudio P. Larrazabal and Sixto T. Pongos.
