## RESOLUTION NO.

A RESOLUTION CONCURRING THE REAPPOINTMENTS OF ATTY. CLETO L EVANNELISTA, JR. AND MR. VICENTE V. REDONA AS THE TOTAL OFFICER AND THE CITY ADMINISTRATOR,
TOTALY, OF THE CITY GOVERNMENT OF ORMOC EFFECTIVE
1975. RESPEC JUNE 3/ .

WHIRITAD this Sanggunian has acknowledged receipt on the 11th July of 1st Indorsement (letter) dated 3 July 1995 from the Honorable Mayor which thus cited:

"Respectfully forwarded X X X the herein reappointments the two (2) coterminous positions due to the reelection the appointing authority for your consideration and confirmation as follows:

- 1. Cleto L. Evangelista, Jr., - City Legal Officer
- 2. Vicente V. Redoffa - City Administrator."

WHEREAS, of importance to state in here are the following provisions of Rep. Act. No. 7160, otherwise known as the Local Government Code of 1991:

"Sec. 481, 2nd Par.. The term of the (City) Legal Officer shall be coterminous with that of the appointing authority."

"Sec. 480, 2nd Par. The term of the (City) Administrator is coterminous with that of the appointing authority."

"Sec. 454, Par. (d). X X X heads of departments and offices shall be appointed (re-appointed) by the City Mayor with the concurrence of the majority of all the sangguniang panlungsod members, subject to civil service laws, rules and regulations. The Sangguniang Panlungsod shall act on the appointment (reappointment) within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."

WHEREAS, forgoing premises considered including submitted civil service papers and other pertinent records, on motion of Kagawao Celso P. Adolfo, Majority Floor Leader, jointly seconded by mga Kagawad Benjamin B. Lladoc and Alfredo F. Capahi; be it
