RESOLUTION NO. 25-17

A RESOLUTION CONCURRING THE REAPPOINTMENTS OF ATTY. CLETO  
L. EVANGELISTA, JR. AND MR. VICENTE V. REDONA AS THE  
CITY LEGAL OFFICER AND THE CITY ADMINISTRATOR,  
RESPECTIVELY, OF THE CITY GOVERNMENT OF ORMOC EFFECTIVE  
JUNE 30, 1995.

WHEREAS, this Sanggunian has acknowledged receipt on the 11th July  
1995 of 1st Inorsement (letter) dated 3 July 1995 from the Honorable  
City Mayor which thus cited:

"Respectfully forwarded X X X the herein reappointments  
of the two (2) coterminous positions due to the reelection  
of the appointing authority for your consideration and  
confirmation as follows:

1. Cleto L. Evangelista, Jr.,  
- City Legal Officer
2. Vicente V. Redoffa  
- City Administrator."

WHEREAS, of importance to state in here are the following  
provisions of Rep. Act. No. 7160, otherwise known as the Local  
Government Code of 1991:

"Sec. 481, 2nd Par. The term of the (City) Legal Officer  
shall be coterminous with that of the appointing  
authority."

"Sec. 480, 2nd Par. The term of the (City) Administrator  
is coterminous with that of the appointing authority."



"Sec. 454, Par. (d). X X X heads of departments and offices shall be appointed (re-appointed) by the City Mayor with the concurrence of the majority of all the sangguniang panlungsod members, subject to civil service laws, rules and regulations. The Sangguniang Panlungsod shall act on the appointment (re-appointment) within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."

WHEREAS, forgoing premises considered including submitted civil service papers and other pertinent records, on motion of Kagawad Celso P. Adolfo, Majority Floor Leader, jointly seconded by mga Kagawad Benjamin B. Lladoc and Alfredo F. Capahi; be it

RESOLVED, to pass a resolution CONCURING THE REAPPOINTMENTS OF ATTY. CLETO L. EVANGELISTA, JR. AND MR. VICENTE V. REDONA AS THE CITY LEGAL OFFICER AND THE CITY ADMINISTRATOR, RESPECTIVELY, OF THE CITY GOVERNMENT OF ORMOC EFFECTIVE JUNE 30, 1995;

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the CSC Regional Director through the CSC Ormoc Field Office, and the HRM Division Office, -all in Ormoc City;
