A RESOLUTION APPROVING ORDINANCE NO. 94-003 S. 1994 OF THE  
BARANGAY COUNCIL OF STO. NINO, ENTITLED "AN ORDINANCE  
REQUIRING ANY PERSON, REAL OR JURIDICAL, RESIDING IN THIS  
BARANGAY, WHO MAY WANT TO ACQUIRE A BARANGAY CLEARANCE, TO  
PAY CLEARANCE FEES AS PRESCRIBED BY THIS ORDINANCE.

WHEREAS, this august Body is in receipt of Ordinance No. 94-003 s.  
1994 of the Barangay Council of Sto. Nino, this city, entitled "An  
Ordinance requiring any person, real or juridical, residing in this  
Barangay, who may want to acquire a Barangay Clearance, to pay Clearance  
Fees as prescribed by this Ordinance";

WHEREAS, this Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited Ordinance at issue (and all other ordinances of the mga
