A RESOLUTION APPROVING DEDINANCE NO. 94-003 S. 1994 OF BORNDAY COUNCIL OF STO. NINO, ENTITLED "AN ORDINANCE REQUIRING ANY PERSON, REAL OR JURIDICAL, RESIDING IN THIS BARANGAY, AND MAY WANT TO ACQUIRE A BARANGAY CLEARANCE, TO PAY CLEARANCE FEES AS PRESCRIBED BY THIS ORDINANCE.

WHEREAS, this asgust Body is in receipt of Ordinance No. 94-003 s. the Exrangay Council of Sto. Niffo, this city, entitled "An requiring any person, real or juridical, residing in this Rarangay, who may want to acquire a Barangay Clearance, to pay Clearance ees as prescribed by this Ordinance";
