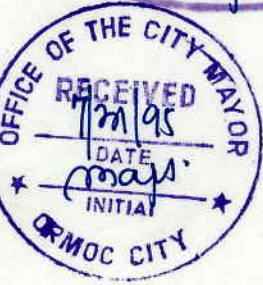
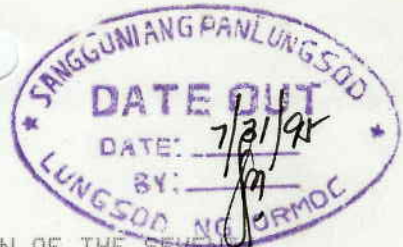

RESOLUTION NO. 95-22

A RESOLUTION RETURNING ORDINANCE NO. 95-04 TO THE
BARANGAY COUNCIL OF LINAO, ORMOC CITY, ENTITLED, "AN
ORDINANCE REQUIRING HEADS OF FAMILIES TO REGISTER WITH
THE BARANGAY SECRETARY, ALL PERSONS WHO MAY TEMPORARILY
RESIDE IN THEIR HOUSES FOR MORE THAN FIFTEEN (15) DAYS,
PROVIDING PENALTIES IN VIOLATION THEREOF," WITH THE
RECOMMENDATION THAT THE PROVISIONS OF SECTIONS 1 AND 2
THEREOF BE RECONCILED.

WHEREAS, this august Body is in receipt of Ordinance No. 95-04 of
the Barangay Council of Linao, this city, entitled, "AN ORDINANCE
REQUIRING HEADS OF FAMILIES TO REGISTER WITH THE BARANGAY SECRETARY, ALL
PERSONS WHO MAY TEMPORARILY RESIDE IN THEIR HOUSES FOR MORE THAN FIFTEEN
(15) DAYS, PROVIDING PENALTIES IN VIOLATION THEREOF";

WHEREAS, the Seventh Sangguniang Panlungsod through the
representation of the Honorable Chairman, Committee on Laws and
Ordinances, has recommended that the said Ordinance be returned to the
barangay of Origin for the reason that the provisions of Sections 1 and
2 thereof be reconciled;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution returning
Ordinance No. 95-04 to the Barangay Council of Linao, this city,
entitled, "AN ORDINANCE REQUIRING HEADS OF FAMILIES TO REGISTER WITH THE
BARANGAY SECRETARY, ALL PERSONS WHO MAY TEMPORARILY RESIDE IN THEIR
HOUSES FOR MORE THAN FIFTEEN (15) DAYS, PROVIDING PENALTIES IN VIOLATION
THEREOF", with the recommendation that the provisions of Sections 1 and
2 thereof be reconciled;
