RESOLUTION NO. 95-25

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO  
SIGN A MEMORANDUM OF AGREEMENT WITH N.F.A. TO PURCHASE  
RICE AND CORNGRITS ON CREDIT FOR CALAMITY RELIEF  
OPERATIONS DURING CALAMITIES.

WHEREAS, this Sanggunian is in receipt of a letter dated 18 July 1995 from the Office of the City Mayor requesting for passage of a resolution authorizing the City Mayor to sign a Memorandum of Agreement to purchase rice and corngrits on credit for calamity relief operations during calamities;

WHEREAS, this request for passage of a resolution is in consonance to a letter dated 4 July 1995 from Mr. J. B. Guevara, Provincial Manager - NFA, Palo, Leyte, wherein this requested resolution shall form part of the Memorandum of Agreement (renewal) for year 1995-96 to be executed by and between NFA and Ormoc City with amendment for provision letter C thereof: "The price of rice/corngrits shall be in accordance with the NFA Consumer's price at the time the authority to issue is approved by the Provincial Manager";

WHEREFORE, foregoing premises considered, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH N.F.A. TO PURCHASE RICE AND CORNGRITS ON CREDIT FOR CALAMITY RELIEF OPERATIONS DURING CALAMITIES;
