this august Body is in receipt of a request from the loporable City Mayor Eufrocino M. Codilla, Sr. to authorize him to sign Neer of Absolute Sale between the City of Ormoc, a Local Government Unit represented by the Honorable City Mayor Eufrocino M. Codilla, Sr., the Sps. Felicisimo Inong and Erlinda Bates involving a parcel of land known as Lot No. 2349-B-2-A-B-1 situated at Brgy. Alegria, Ormoc City, consisting of 122 sq. meters and covered by TCT No. 22183 to be used as Road-Right-Of-Way of the City Government of Ormoc excluding the cost or value of any improvement therein;

WHEREAS, per Resolution No. 04-94 of the Appraisal Committee dated 29 July 1994 said lot was duly appraised at P250.00 per sq. meter;
