RESOLUTION NO. 26

A RESOLUTION CONFIRMING AND RATIFYING THE DEED OF ABSOLUTE SALE ENTERED INTO BETWEEN THE CITY OF ORMOC, A LOCAL GOVERNMENT UNIT REPRESENTED BY THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., AND THE SPS. FELICISIMO INONG AND ERLINDA BATES FOR A PARCEL OF LAND KNOWN AS LOT NO. 2349-B-2-A-B-1, EXCLUDING THE COST OR VALUE OF ANY IMPROVEMENT THEREIN, SITUATED AT BRGY. ALEGRIA, ORMOC CITY WITH AN AREA OF 112 SQ. METERS AND COVERED BY TCT NO. 22183 TO BE USED AS ROAD-RIGHT-OF-WAY.

WHEREAS, this august Body is in receipt of a request from the Honorable City Mayor Eufrocino M. Codilla, Sr. to authorize him to sign a Deed of Absolute Sale between the City of Ormoc, a Local Government Unit represented by the Honorable City Mayor Eufrocino M. Codilla, Sr., and the Sps. Felicisimo Inong and Erlinda Bates involving a parcel of land known as Lot No. 2349-B-2-A-B-1 situated at Brgy. Alegria, Ormoc City, consisting of 122 sq. meters and covered by TCT No. 22183 to be used as Road-Right-Of-Way of the City Government of Ormoc excluding the cost or value of any improvement therein;

WHEREAS, per Resolution No. 04-94 of the Appraisal Committee dated 29 July 1994 said lot was duly appraised at P250.00 per sq. meter;

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc, through the representation of the Honorable Chairman, Committee on Public Properties, has considered said sale as valid and reasonable, hence confirmation thereof by this august Body is in order;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by Kagawad Alfredo F. Capahi and Angelyn R. Paca; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution confirming and ratifying the Deed of Absolute Sale entered into between the City of Ormoc, a Local Government Unit represented by the Honorable City Mayor Eufrocino M. Codilla, Sr., and the Sps. Felicisimo Inong and Erlinda Bates of land known as Lot No. 2349-B-2-A-B-1, excluding the cost or value of any improvement therein, situated at Brgy. Alegria, Ormoc City with an area of 122 sq. meters and covered by TCT No. 22183 to be used as Road-Right-Of-Way.
