A RESOLUTION APPROVING ORDINANCE NO. 95-003, SERIES OF 1995 OF THE BARANGAY COUNCIL OF DONA FELIZA MEJIA, THIS CITY ENTITLED "AN ORDINANCE PROHIBITING THE INDISCRIMINATE THROWING OR DISPOSING OF GARBAGE WITHIN THE JURISDICTION OF BARANGAY DONA FELIZA MEJIA, PROVIDING PENALTY FOR THE VIOLATION THEREOF."
