A RESOLUTION REQUESTING THE OFFICE OF THE PRESIDENT, HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, FOR A DONATION OF THREE (3) UNITS OF FIRE TRUCKS (TWO (2) UNITS OF MODERN FIRE TRUCKS AND ONE (1) UNIT SUPER TANKER) TO AUGMENT THE INADEQUATE AND ANTIQUATED FIRE FIGHTING EQUIPMENT OF THE ORMOC CITY FIRE DEPARTMENT.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor Eufrocino M. Codilla, Sr., dated 25 July 1995, addressed the Honorable Members of the Seventh Sangguniang Panlungsod ng Ormoc, thru the Honorable Vice Mayor & Presiding Officer, requesting for passage of a resolution requesting His Excellency, President Fidel V. Ramos for a donation of two (2) units Modern Fire Trucks and one (1) unit Super Tanker to augment the inadequacy and inefficiency of Ormoc City's fire fighting units;

WHEREAS, an assessment as to the fire which occurred last July 20, 1995 in this city has pointed out the failure of the city's firemen to easily combat the fire with their present inadequate and inefficient fire fighting facilities;

WHEREAS, in order to modernize and augment Ormoc City's fire fighting facilities, the need for said trucks and tanker is very necessary for it does not only benefit Ormoc City but also its neighboring towns or municipalities;

NOW, THEREFORE, foregoing premises considered, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Police, Fire and Public Safety, severally seconded by mga Kagawad Alfredo F. Capahi, Benjamin B. Lladoc and Sotero M. Pepito; be it






