A RESOLUTION GRANTING THE APPLICATION FOR PRELIMINARY APPROVAL, LOCATIONAL CLEARANCE AND APPLICATION FOR DEVELOPMENT PERMIT OF THE ORMOC SUBDIVISION PROJECT OF THE CITY GOVERNMENT OF ORMOC, INVOLVING LOTS 5362-A, 5362-B, 5362-C AND 5362-D-2 (LRC) PSD-236950 LOCATED AT BARANGAY SAN ISIDRO, ORMOC CITY, WITH A TOTAL AREA OF 40,674 SQUARE METERS, COVERED BY TCT NOS. 24619, 24620, 24621 AND 24676 CONTAINING 189 LOTS EXCLUDING PARKS AND PLAZA, COMMUNITY FACILITIES AND ROAD LOTS.

PRESENTED for consideration by the august Body is the following:

An application for Preliminary Approval, Locational Clearance and Development Permit of the Ormoc Subdivision Project of the City Government of Ormoc involving Lots 5362-A, 5362-B 5362-C and 5362-D-2 (LRC) Psd-236950 owned by the City Government and located at Brgy. San Isidro, Ormoc City, with total area of 40,674 sq. meters, covered by TCT Nos. 24619, 24620, 24621 and 24676 containing 189 lots excluding parks and plaza, community facilities and road lots.

WHEREAS, this august Body has found out the said collective application to be in order, with favorable comments as to site inspections, other submitted documents for this proposed complex subdivision project have shown "compliance with the provisions of P.D. 957, R.A. 7279, E.O. 648, R.A. 7160 and their implementing rules and regulations";
