A RESOLUTION APPROVING OF DINANCE NO. 94-001 OF PROVIDED THE USE OF ELECTRICITY, PESTICIDES AND OTHER POISONOUS SUBSTANCES IN RIVERS, STREAMS AND OTHER PUBLIC WATERS WITHIN THE JURISDICTION OF BARANGAY SANTO VINO, FOR THE PURPOSE OF CATCHING FISHES AND OTHER ASUATIC ASSOURCES, PROVIDING PENALTIES THEREOF."

WHEREAS, this august Body is in receipt of Ordinance No. 94-001 of Barangay Council of Sto.
