A RESOLUTION APPROVING ORDINANCE NO. 94-001 OF THE
BARANGAY COUNCIL OF STO. NINO, ENTITLED "AN ORDINANCE
PROHIBITING THE USE OF ELECTRICITY, PESTICIDES AND
OTHER POISONOUS SUBSTANCES IN RIVERS, STREAMS AND OTHER
PUBLIC WATERS WITHIN THE JURISDICTION OF BARANGAY SANTO
NINO, FOR THE PURPOSE OF CATCHING FISHES AND OTHER
AQUATIC RESOURCES, PROVIDING PENALTIES THEREOF."

WHEREAS, this august Body is in receipt of Ordinance No. 94-001 of
