RESOLUTION NO. 95-38

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AS VENDEE, A DEED OF ABSOLUTE SALE WITH MRS. JACINTA VDA DE CAMAQUIN AS VENDOR INVOLVING LOT NO. 2243-E-2 SITUATED AT BARANGAY PUNTA, ORMOC CITY, TO BE USED AS ROAD-RIGHT-OF-WAY.

WHEREAS, this sanggunian is in receipt of a letter dated 25 July 1995 from the Honorable City Mayor requesting for an authority to sign for and in behalf of the City Government of Ormoc as vendee a Deed of Absolute Sale with Mrs. Jacinta Vda de Camaquin as vendor involving Lot No. 2243-E-2 covered by Transfer Certificate of Title No. 26409 with an area of Two Hundred Ninety four (294) sq. meters located at Barangay Punta, this city for road-right-of-way purposes;

WHEREAS, per Resolution No. 17-95 dated 10 July 1995 of the City Appraisal Committee, said Lot No. 2243-E-2 was duly appraised at P300.00 per sq. meters; and through a Certification of the City Engineer dated 13 July 1995, the same lot is "affected by a 20.00 m. wide existing road";

WHEREAS, the OIC-City Treasurer through a Certification dated 17 July 1995 has certified that "fund is available for the Road Right of Way Claim of Mrs. Jacinta Vda de Camaquin";

NOW THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Benjamin B. Lladoc and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor, Eufrocino M. Codilla, Sr., to sign for and in behalf of the City Government of Ormoc as Vendee a Deed of Absolute Sale with Mrs. Jacinta Vda de Camaquin as vendor involving Lot No. 2243-E-2 situated at Barangay Punta, Ormoc City to be used as road-right-of-way;
