ESOLUTION NO. 95

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, EUROCINO N. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE NITY VOVERNMENT OF DRMOC, AS VENDEE, A DEED OF A RESOLUTION ASSOLUTE SALE OF A PORTION OF THE PROPERTY OWNED BY THE HEIRS OF MS. JACINTA VALLE REPRESENTED BY VICENTE VALLE TRINIDAD, CONSISTING OF 1,653 SQUARE METERS COVERED BY NO. 1241 TO BE USED AS ROAD-RIGHT-OF-WAY, VIDEL, THAT PAYMENT THEREOF SHALL ONLY BE MADE AFTER PREVIDED THE BACKFILLING THEREOF TO BE BORNE BY THE VENDOR.

WHEREAS, this sanggunian is in receipt of a letter dated 30 May 1985 from the Honorable City Mayor relative to the raod-right-of-way claim of Mr. Vicente V. Trinindad consisting of 1,653 square meters covered by TCT No. 12619 to be used as Road-Right-Of-Way located at Barangay Linao, this city;

WHEREAS, per Resolution No. 8-93 of the City Appraisal Committee dated 4 November 1993 said lot was duly appraised at ₱250.00 per square meter; and through 1st indorsement dated 11 August 1995 the City Engineer has stated that "Lot No. 11-B, with an area of 844 sq. m. still requires 1,266 cubic meters backfilling to be open to traffic";

official documents evidencing absolute transfer of ownership of said property is indispensable for records file in government office/s concerned;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Fernando P. Parrilla and Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor, Eufrocino M. Codilla, Sr., to sign for and in behalf of the gity Government of Ormoc, as vendee, a deed of absolute sale of a portion of

the property owned by the heirs of Ms. Jacinta Valle represented by Vicente Valle Trinidad, consisting of 1,653 square meters covered by TCT No. 12619 to be used as Road-Right-Of-Way, provided, that payment thereof shall only be made after the backfilling thereof to be borne by the vendor;
