B. Lladoc and Alfredo F. Capahi; be it

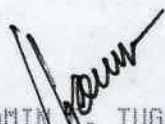
RESOLVED, AS IT IS HEREBY RESOLVED, to approve Ordinance No. 12 s.

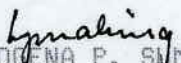

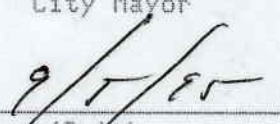
