RESOLUTION NO. 95-49

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF RAPANGAY IPIL, ORNOC CITY, ITS ORDINANCES NOS. 1 AND 2, BOTH SERIES OF 1995, ENTITLED, "AN ORDINANCE REGULATING FISHING AND/OR FISHERIES IN THE BARANGAY IPIL, ORMOC CITY AND OTHER PURPOSES", AND "AN ORDINANCE PROHIBITING ISHING ACTIVITIES IN ANY MANNER WITHIN THE ARTIFICIAL RESPECTIVELY, FOR THE FOLLOWING REASONS, TO WIT: (1) PER OPINION OF OUR CITY LEGAL OFFICER, RARANCAY ORDINANCES WHICH REGULATE FISHING ACTIVITIES WITHIN THE TERRITORIAL WATERS OF ORMOC CITY "SUPERFLUITY" CONSIDERING THAT THE SANGGUNIANG PANLUNGSOD NG ORMOC HAS ALREADY PASSED ORDINANCE NO. 38 S. 1993 WHICH REGULATES FISHING ACTIVITIES WITHIN THE TERRITORIAL WATERS OF ORMOC CITY; AND, (2) THE PENALTY PROVIDED FOR IN ORDINANCE NO. 2 WHICH IS "A FINE OF NOT LESS THAN ONE THOUSAND PESOS (P1,000.00) DR MORE DEPENDING ON DAMAGED BEING MADE" IS ULTRA VIRES, AS THE PENALTY WHICH BARANGAY COUNCILS ARE AUTHORIZED TO IMPOSE UNDER ARTICLE 101, (A) (14) OF THE RRILGC IS "PRESCRIBE FINES IN AMOUNTS NOT EXCEEDING ONE THOUSAND (<u>№1,000.00</u>) FOR VIOLATION OF ORDINANCES." (UNDERSCORING SUPPLIED.).

WHEREAS, this sanggunian is in receipt of Ordinances Nos. 1 and 2, Series of 1995, of the Sangguniang Barangay of Barangay Ipil, Ormoc City, entitled, "AN ORDINANCE REGULATING FISHING AND/OR FISHERIES IN THE BARANGAY IPIL, ORMOC CITY AND OTHER PURPOSES" and "AN ORDINANCE PROHIBITING FISHING ACTIVITIES IN ANY MANNER WITHIN THE ARTIFICIAL REEFS AREA" which are submitted for review as mandated by the provision of Article III, paragraph (a) of the Rules and Regulations Implementing the Local Government Code of 1991 (RRILGC);

WHEREAS, this Sanggunian has already passed Ordinance No. 38 s. 1993, entitled: "AN ORDINANCE REVISING ORDINANCE NO. 23, SERIES OF 1990, REGULATING FISHING AND/OR FISHERY PRIVILEGES IN THE CITY OF ORMOC, AND FOR OTHER PURPOSES", which regulates all fishing activities within the territorial waters of Ormoc City;

WHEREAS, our City Legal Officer has opined that Ordinances passed by the Sangguniang Barangay regulating fishing activities within the territorial waters of Ormoc City are "SUPERFLUITY";

WHEREAS, Article 101, (a) (14) of the RRILGC, provides: "Prescribe fines in amounts not exceeding One Thousand Pesos (£1,000.00) for violation of barangay ordinances", hence, the penalty provided for in Ordinance No. 2 s.1995 of the Sangguniang Barangay of Barangay Ipil, Ormoc City, which is a "fine of not less than One Thousand Pesos (£1,000.00) or more depending on damaged being made" is UNLAWFUL;

WHEREAS, the provisions in aforementioned Ordinance No. 1, 5, 1995 of the Sangguniang Barangay of Barangay Ipil, Ormoc City, pertaining to "GARBAGE AND WASTE DISPOSAL", Sections 3, and 3.8 thereof, are in order and may therefore be passed as a separate ordinance;

WHEREFORE, foregoing premises considered, on motion of Kagawad Gregorio A. Yrastorza, Jr., Member, Committee on Laws & Ordinances, severally seconded by mga Kagawad Gotero M. Pepito, Alfredo F. Capahi and Claudio P. Larrazabal; be it,

RESOLVED, to pass a resolution RETURNING TO THE SANGGUNIANG BARANGAY OF BARANGAY IPIL, ORMOC CITY, ITS ORDINANCES NOS. 1 AND 2, BOTH SERIES OF 1995, ENTITLED, "AN ORDINANCE REGULATING FISHING AND/OR FISHERIES IN THE MARANGAY IPIL, ORMOC CITY AND OTHER PURPOSES", AND "AN ORDINANCE PROFIBITION FISHING ACTIVITIES IN ANY MANNER WITHIN THE ARTIFICIAL RESPONSE AREA", RESPECTIVELY, FOR THE FOLLOWING REASONS, TO WIT: (1) PEN OPINION OF OUR CITY LEGAL OFFICER, BARANGAY ORDINANCES WHICH REGULATE FISHING ACTIVITIES WITHIN THE TERRITORIAL WATERS OF ORMOC CITY AND "SUPERFLUITY" CONSIDERING THAT THE SANGGUNIANG PANLUNGSOD NG ORMOC HAS ALREADY PASSED ORDINANCE NO. 38 S. 1993 WHICH REGULATES PISHING ACTIVITIES WITHIN THE TERRITORIAL WATERS OF ORMOC CITY; AND, (2) THE PENALTY PROVIDED FOR IN ORDINANCE NO. 2 WHICH IS "A FINE OF NOT LESS THAN ONE THOUSAND PESOS (P1,000.00) OR MORE DEPENDING ON DAMAGED BEING MADE" IS DITRA VIRES, AS THE PENALTY WHICH BARANGAY COUNCILS ARE AUTHORIZED TO IMPOSE UNDER ARTICLE 101, (A) (14) OF THE RRILGC IS "PRESCRIBE FINES IN AMOUNTS NOT EXCEEDING ONE THOUSAND PESOS (P1.000.00) FOR VIOLATION OF BARANGAY ORDINANCES." (UNDERSCORING SUPPLIED.).
