WHEREAS, this august Body is in receipt of a letter dated 21 August from the Honovable City Mayor the full text of same is hereunder ited as follows:

To avoid inconvenience and expedite withdrawals of city government funds, the undersigned, finds it necessary to appoint and designate another depository bank of the city government money.

In view of this, may I respectfully request the august Body for the passage of a resolution authorizing the OIC-City Treasurer, Mr. Jesus F. Capahi to transfer the Internal

Revenue Allotment (IRA) of Ormoc City from the Development Bank of the Philippines to the Land Bank of the Philippines in the amount of 5 million pesos every month.
