A RESOLUTION PLEDGING LOCAL COUNTERPART SUPPORT TO THE
PUBLIC MARKET DEVELOPMENT PROGRAM PROPOSED FOR
ASSISTANCE FROM THE JAPANESE INTERNATIONAL COOPERATION
AGENCY (JICA).

WHEREAS, the Honorable Acting City Mayor Benjamin F. Tugonon, SP
Presiding Officer, is in receipt of a telegram from Director Roberto C.
Abejero, DILG, Region VIII, Tacloban City, dated 29 August 1995
requiring this august Body to submit a resolution pledging local
counterpart support to the City's Public Market Development Program
proposed for assistance from the Japanese International Cooperation
Agency (JICA);

WHEREAS, a request has been made by this august Body to the
Regional Development Council (RDC), Tacloban City, to strongly and
favorably endorse the proposed Public Market and Slaughterhouse Project
for funding with the JICA through SP Resolution No. 92 dated 15 June
1995, a copy hereto attached;

the local counterpart which includes drainage, land development and
