RESOLUTION NO. 95-50

A RESTLUTION ADOPTING, SUF'PORTING AND ENDORSING THE RESOLUTION OF THE PHILIPPINE COUNCILORS' LEAGUE PASSED ITS NATIONAL CONGRESS HELD ON AUGUST 30 TO SEPTEMBER 1, 1995 AT THE PHILIPPINE INTERNATIONAL CONVENTION CENTER (PICC), MANILA, ENTITLED "A RESOLUTION PROTESTING IN THE STRONGEST TERMS THE FRENCH NUCLEAR FEST IN THE SOUTH PACIFIC, ASKING THE FRENCH COVERMENT THROUGH THE FRENCH EMBASSY IN MANILA TO CANCEL OR ABANDON THE SAME."

MEREAS, the Philippine Councilors' League during its National Congress held on August 30, 31 and September 1, 1995 at the Philippine International Convention Center, Metro Manila passed the hereinbelow quoted resolution, to wit:

"Philippine Councilors' League

RESOLUTION NO.

A RESOLUTION PROTESTING IN THE STRONGEST TERMS THE NUCLEAR TEST IN THE SOUTH PACIFIC, ASKING THE FRENCH GOVERNMENT THROUGH THE FRENCH EMBASSY IN MANILA TO CANCEL OR ABANDON THE SAME.

WHEREAS, the French government is set to undertake series of nuclear tests in the South Pacific starting this September 1995 apparently to enhance it's nuclear capability;

WHEREAS, the French nuclear test is being conducted ironically at a time when the cold war has ended, when there is a global consensus on disarmament and the prospect of a lasting world peace is at its brightest;

WHEREAS, while most of the countries of the world today, the Philippines included, are busy pursuing socio-economic programs for sustainable development, the French Government is preoccupied with a counter-productive activity that could undermine and negate such development efforts;

WHEREAS, the French nuclear test could wreck havec to the environment including the atmosphere that could destroy the earth's life-sustaining eco-system;

WHEREAS, the French nuclear test could inflict irreparable damage to aquatic life and marine resources in the Pacific Ocean which are the food and livelihood base of the people of many countries in the region;

WHEREAS, as various research studies reveal, the French nuclear test could directly and indirectly endanger the health and safety of the inhabitants of the countries in the Pacific region with long-term radio active induced damage and injuries;

WHEREAS, the French nuclear test would surely disturb the peace, tranquility and stability of the Pacific region as it poses grave threat to international security;

WHEREAS, the French nuclear test and all nuclear tests for that matter, are useless, senseless and dangerous exercise that depletes and wastes valuable resources which could otherwise be used for the benefit of mankind.

NOW, THEREFORE, BE IT RESOLVED, THAT, the Philippine Councilors' League protest as it hereby protests in the strongest terms the French nuclear test in the South Pacific and asks the French government through the French Embassy in Panila to cancel or abandon the same.
