RESOLUTION NO. 95-57

A RESOLUTION ADOPTING, SUPPORTING AND ENDORSING THE RESOLUTION OF THE PHILIPPINE COUNCILORS' LEAGUE PASSED DURING I'S NATIONAL CONGRESS HELD ON AUGUST 30 TO SEPTEMBER 1, 1995 AT THE PHILIPPINE INTERNATIONAL CONVENTION CENTER (PICC), MANILA, ENTITLED "A RESOLUTION DROING THE FILIPINO PEOPLE TO BOYCOTT FRANCE-MANE OR RELATED PRODUCTS AND SERVICES UNTIL THE RENCE GOVERNMENT CANCEL OR ABANDON ITS PLAN TO CONDUCT NUCLEAR TEST IN THE SOUTH PACIFIC."

WHEREAS, the Philippine Councilors' League during its National Congress held on August 30, 31 and September 1, 1995 at the Philippine International Convention Center, Metro Manila, passed the hereinbelow quoted resolution, to wit:

"Philippine Councilors' League

RESOLUTION NO.

A RESOLUTION URGING THE FILIPINO PEOPLE TO BOYCOTT FRANCE-MADE OR RELATED PRODUCTS AND SERVICES UNTIL THE FRENCH GOVERNMENT CANCEL OR ABANDON ITS PLAN TO CONDUCT NUCLEAR TEST IN THE SOUTH PACIFIC.

WHEREAS, despite world-wide protests and clamor, the French Government appears to be determined in pursuing nuclear tests in the South Pacific this September 1995;

could WHEREAS, the French nuclear tests irreversible and irreparable damage and injuries catastrophic proportion to man and his environment;

WHEREAS, the French nuclear test pose serious threat to the peace and security of the world;

WHEREAS, the French nuclear test is a senseless, useless, and dangerous exercise that could lead to man's own destruction;

WHEREAS, in order to stop this gross stupidity and recklessness, there is a need to sustain people's protest and agitation against the nuclear test and apply pressures on the French authorities;

NOW, THEREFORE, be it resolved, that the Philippine Councilors' League urge as it hereby urges the Filipino People to Boycott France-made or related products and services until the French Government cancel or abandon its plan to conduct nuclear test in the South Pacific.

WHEREFORE, premises considered, on MASS MOTION of the Body and with OVERWHELMING SECONDS; be it

RESCLUED, to pass a resolution adopting, supporting and endorsing the resolution of the philippine councilors' league passed during its national congress HELD on august 30 to september 1, 1995 at the philippine international convention center (picc), manila, entitled "A resolution orging the pilipino people to boycott france-made or related products and services until the French Government cancel or abandon its plan to conduct anclear test in the south pacific.";

ENACTED, September 7, 1995.

REGOLVED, FURTHER, to furnish copies of this resolution, one each, to his Excellency, the French Ambassador to the Philippines, French Embassy, Metro Manila; the Secretary of the Department of Trade and and Industry, Metro Manila, the Honorable City Mayor, Eufrocino M. Codilla, Sr., the Publishers of the Different Newspapers in Ormoc City; and others concerned.
