RESOLUTION NO. 95-58

A RESOLUTION RESPECTFULLY REQUESTING AND ENCOURAGING TAXPAYERS DOING BUSINESS IN ORMOC CITY, ALTHOUGH THEIR PRINCIPAL OFFICE IS SITUATED OUTSIDE ORMOC CITY, TO FILE AND PAY THEIR TAXES, ESPECIALLY THE FOLLOWING: EXCISE TAX ON ALCOHOL PRODUCTS; EXCISE TAX ON MINERAL PRODUCTS; PERCENTAGE TAXES; WITHHOLDING TAXES ON: 1) GOVERNMENT MONEY PAYMENTS 2) COMPENSATION: TOP 5,000 TAXPAYERS; CREDITABLE EXPANDED WITHHOLDING TAX; FINAL WITHHOLDING TAX; DOCUMENTARY STAMP TAXES; AND OTHER TAXES THAT MAY BE ALLOWED BY THE COMMISSIONER OF INTERNAL REVENUE, AT THE REVENUE DISTRICT OFFICE NO. 89, ORMOC CITY.

WHEREAS, this august body is in receipt of a letter dated August 11, 1995, from Revenue District Officer, Rolando R. Sanico, requesting among others, to pass "A resolution requesting and encouraging all persons engaging in business within Ormoc City, particularly those classified as large Taxpayers and those with principal place of business situated outside Revenue District No. 89, Ormoc City, to file and pay their taxes due from their Operations here in the district";

WHEREAS, it is the sense of this august Body, that it is only but fitting and proper that taxpayers doing business in Ormoc City, regardless of the location of their principal offices, should file and pay their taxes due from their operations herein, considering the governmental services of Ormoc City that they enjoy;
