RESOLUTION NO. 59

A RESOLUTION RETURNING ORDINANCE NO. 95-001 S. 1995 OF BARANGAY ESPERANZA WITH THE INTORMATION THAT PER 3RD INDORSEMENT OF THE CITY LEGAL OFFICER, SUBJECT TAX ORDINANCE IS CONTRARY TO SEC. 133 PAR. (a) OF THE LOCAL ORDINANCE IS CO GOVERNMENT CODE.

Wicker. this sanggunian is in receipt of Ordinance No. 95-001 s. of the Barangay Council of Esperanza, this city, entitled "An Ordinand imposing a one percent (1%) tax on the commercial activities in he carangay"; implements and other agro-industrial machineries,

the City Legal Officer, through 3rd Indorsement dated 27 h 1795, has made the following comments:

"X X X Ordinance No. 95-001 of Barangay Esperanza has no effect whatever for being contrary to Sec. 133 par. (a) of the Local Government Code which provides:

"Sec. 133. Common Limitation on the Taxing Powers of Local Government Units. - Unless otherwise provided herein, the exercise of the taxing powers of provinces, cities, municipalities and barangays shall not extend to the levy of the following:

"a) Income tax, except when levied on banks and other financial institutions.

"The tax imposed by Ordinance No. 95-001 is in reality on income tax as shown by Sections 1 and 2 thereof."

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by Kagawad Nestor C. Penserga; be it
