A RESOLUTION APPROVING ORDINANCE NO. 95-04 OF THE

ENTITLED, "AN ORDINANCE REQUESTING HEADS OF FAMILIES TO
REGISTER WITH THE BARANGAY SECRETARY ALL PERSONS WHO
MAY TEMPORARILY RESIDE IN THEIR HOUSE FOR MORE THAN
FIVE (5) DAYS PROVIDING PENALTIES IN VIOLATION
THEREOF."
