APPROVING ORDINANCE NO. 95-04 OF THE A RESOLUTION G BARANDAY OF BARANGAY LINAD, ORMOC CITY, AN ORDINANCE ECQUESTING HEADS OF FAMILIES TO SANDSUNTANG KITH THE BARANGAY SECRETARY ALL PERSONS WHO NAY TENFORATILY RESIDE IN THEIR HOUSE FOR MORE THAN FIVE (5) DAYS PROVIDING PENALTIES IN VIOLATION HENERF.
