RESOLUTION NO. 95-68

A RESOLUTION RETURNING TO THE SANGGUMIANG BARANGAY OF BARANGAY R.M. TAN, ORYDOC CITY, ITS BARANGAY TAX BARANGAY R.M. TAN, ORMOC CITY, ITS BARANGA, ORDINANCE IMPOSING ORDINANCE NO. 95-95, ENTITLED, "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRINTINGE RAVELS, AND OTHER OUTDOOR ADVERTISEMENTS, PRIVILEGE RAVELS, AND THER OUTDOOR ADVERTISEMENTS, BARANGAY PERMITS", WITH THE REQUEST THAT THE BLANK SPACE FOR THE DATE OF ITS PUBLIC FARING, AS PREVIDED, BE FILLED UP, OTHER NOTATIONS ENG EMP ASIZED IN THIS RESOLUTION, AS RESOLVED.

WHEREAS this august Body is in receipt from the Sangguniang Barangay R.M. Tan, this city, its Barangay Tax Ordinance No. 95-05, entitled, "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, RILLBOARDS, SIGNBOARDS, PRIVILEGE PANELS, AND OTH ADVERTISEMENTS, BARANGAY CLEARANCES AND BARANGAY PERMITS"; OTHER

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD, in SESSION, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, have observed a materials defect in said Ordinance, i.e., it's being without a specific date of public hearing, hence, be returned to the Sangguniang Barangay of Origin for completion;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by mga Kagawad Angelyn R. Paca and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to return to the Sangguniang Barangay of Barangay R.M. Tan, this city, its Barangay Tax Ordinance No. 95-05, entitled, "An Ordinance imposing taxes on retailers, billboards, signboards, privilege panels, and other outdoor advertisements, Barangay Clearances and Barangay Permits", with the request that the blank space for the date of the public hearing as provided in the aforementioned ordinance be filled up, that is, if such public hearing was actually

held. Please take note that as provided for in Article 276, par. (b) (c) "No tax ordinance or revenue measure shall be enacted or approved in the absence of a public hearing duly conducted in the manner provided in this article". Also, in Section 5 thereof, the word "displaced" be changed to "displayed".
