Alfaro, Jr., Chairman and Member, respectively, of the Committee on Infrastructures, has verified and affirmed that the afore-enumerated projects are prioritized projects considered urgent to the needs of the mga barangay based on results of the barangay visits conducted by the City Mayor and other city officials, and out of the studies made by the City Planning & Development Office, the Committees of Infrastructures and Finance of this sanggunian, and ultimately, out of the agreement reached during conference of the mga barangay chairmen and other officials;

NOW, THEREFORE, on joint motion presented by mga Kagawad Claudio P. Larrazabal and Jose C. Alfaro, Jr., Chairman & Member (respectively), Committee on Infrastructures, severally seconded by mga Kagawad Sotero M. Pepito, Alfredo F. Capahi and Mariano Y. Corro; be it




