#### RESOLUTION NO. 95-72

A RESOLUTION APPROVING ORDINANCE NO. 95-01 ENTITLED, "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC. FROM ROAMING AROUND THE BARANGAY SITE, AND OTHER PUBLIC AND PRIVATE PLACES, PROVIDING PENALTIES IN VIOLATION THEREOF" AND TAX ORDINANCE NO. 03 S. 1995 ENTITLED, "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, ADVERTISEMENT", OF THE SANGGUNIANG BARANGAY OF KADAOHAN, THIS CITY.

WHEREAS, this august Body is in receipt of Ordinance No. 95-01 entitled "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC.
