## ESOLUTION NO. 95-72

REVOLUTION APPROVING ORDINANCE NO. 95-01 ENTITLED, "AN ORD WANTE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS. GOATS CARABAGS COWS, HORSES, ETC. FROM ROAMING AROUND THE BANANCAY SITE, AND OTHER PUBLIC AND PRIVATE PLACES, ROVIDIAS PENALTIES IN VIOLATION THEREOF" AND TAX ORDINANCE NO. 03 S. 1995 ENTITLED, "AN ORDINANCE MPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, ADVERTISEMENT", OF THE SANGGUNIANG BARANGAY KADAOHAN, THIS CITY.

WHEREAS, this august Body is in receipt of Ordinance No. 95-01 cocitled "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC. FROM ROAMING AROUND THE BARANGAY SITE, AND OTHER PUBLIC AND PRIVATE PLACES, PROVIDING PENALTIES IN VIOLATION THEREOF" AND TAX ORDINANCE NO. 03 S. 1995 ENTITLED, "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, ADVERTISEMENT", of the Sangguniang Barangay of Kadaohan, this city;
